### AGREEMENT FOR THE SUPPLY OF ELECTRICITY/WATER TO A PREMISES \*OOREENKOMS VIR DIE VERSKAFFING VAN ELEKTRISITEIT / WATER

ENTERED INTO BY AND BETWEEN IMPACT METER SERVICES (herein after called the service provider) AND THE APPLICANT WHOSE PARTICULARS APPEAR HERE ABOVE, (herein after referred to as the consumer), THE PARTIES HEREBY AGREE AS FOLLOWS:

- \* The consumer accepts the standard terms and conditions of the service provider for the provision of an electricity / water supply to a premises. By signing this agreement, the consumer acknowledges receipt of a copy of those terms and conditions without any alteration whatsoever to any clause contained therein. (Subject to Clause 13).
  - \* The consumer agrees that in the event of the service provider having to institute or defend any legal process or debt collection proceedings, arising from this agreement or the relationship between the parties, the consumer will be liable for all legal costs on the scale as between attorney and client and/or debt collectors commission charges.
  - \* The consumer is herewith informed of the service provider's policy to list all persons who fail to pay any monies due to the service provider by the prescribed date, with a credit reference bureau, and that such information will be available to other credit grantors.
  - \* The consumer consents to a credit check on his person and/or business and accepts that the rendering of services in terms of this agreement is subject to the confirmation of the details supplied herein, and receipt of all supporting documents as required by the service provider.
  - \* If this agreement is signed for a legal person, the signature hereof binds himself as surety and principle debtor in favour of Impact Meter Services for due fulfillment of all liabilities which may now be or at any time become due and payable and hereby renounces the benefits of division, excussion and no value received, the meaning of which he declare himself to be fully acquainted with.
